3. Authorize Oak Knolls Water Main Replacement Project Award

Tom Zaharris, Project Manager, presented the bid summary and Recommendation of Award. The lowest responsive bid is from Solid Rock Construction in the amount of \$240,132.

M/S: [Bambino/Schabarum] 1) Authorize award of the contract to the responsive bidder, as presented and determined following the bid evaluation process; (2) Authorize the General Manager to execute a contract with the selected contractor, contingent upon receipt and verification of all required bonds and insurance; and (3) Authorize the General Manager to approve contract change orders in an amount not to exceed ten percent (10%) of the original construction contract value.

4. Authorize Request for Qualifications for Combined Urban Water Management Plan and Master Plan Update

David Coxey, General Manager, summarized the regulatory requirements for a new Urban Water Management Plan and need to update the Master Plan. He noted that considerable overlap of effort exists and therefore it makes sense to combine the two for efficiency and cost savings. A draft Request for Qualifications was presented.

M/S: [Schabarum/Bambino] Authorize the General Manager, or designee, to issue a Request for Qualifications (RFQ) to solicit proposals from qualified consulting firms for professional services to develop a combined Urban Water Management Plan and Master Plan Update.

5. Water Supply and Production Report

The General Manager presented the water supply and production update with the current eight station index and major water supply reservoirs from the California data exchange. The Central Valley Project Summary of Water Supply Allocation and 5-Year Cumulative Water Production graph was presented.

7. Manager's Report

The General Manager report included an update on operations, maintenance activities and deferred maintenance backlog. The state water board has released the update to the Bay-Delta Water Quality Control Plan that includes negotiated agreements, known as "healthy rivers and landscapes" or HRL, previously known as "voluntary agreements," as well as an unimpaired flows approach. The adoption and implementation have broad and serious implications for water supply, supply reliability and shortage impacts. Federal workforce reductions are continuing with serious impacts to the Bureau of Reclamation. It is my understanding that remaining staff is currently stretched thin and focused on operations, mission critical and public health and safety functions. The District recently promoted a Meter Reader to a D1 position and Lyle Leonard was hired as a Meter Reader with prior water agency experience. With the adopted of the revised Cross Connection Control Policy, staff is busy with updates to the program and implementation. An example letter for customers with single check devices that must be replaced with new Reduced Pressure Principle Detector Assembly (RPDA) devices by January of 2034 is included in the board packet. Other regulatory activities include water conservation and water loss evaluation and tracking. Compliance with new standards will be extremely challenging. There have been some conservation related updates to the website for customer outreach. Informational items in the packet include the California Farm Water Coalition 2024 Impact Report and a draft cross connection letter for customers with single check devices.
